I, the undersigned, understand the dangers and risks involved with participation or being a spectator with the General Recreation Programs, including Aquatics Programs, Gymnastics/Tramp Programs, and Climbing Programs. The Fraser Valley Metropolitan Recreation District (FVMRD) strives to provide a safe environment for its Gymnastics/Tramp participants. However, it is important for the participant (or his or her legal guardian, if the participant is under 18), to understand that even with safety measures, participation in Gymnastics/Tramp programs involves unavoidable exposure to an inherent risk of injury. In consideration of being permitted by the Fraser Valley Metropolitan Recreation District to either participate in or be a spectator with the Programs, I hereby assume all risks and release on my minor children present. I further release all officials, supervisors, employees, and other agency personnel from any claim whatsoever, including negligence, on account of first aid treatment, or services render to my minor children during or after such described participation or while acting as a spectator. This general release shall apply until revoked or canceled in writing by the undersigned.

AUTHORIZATION FOR EMERGENCY CARE: I, the undersigned, hereby give permission to the Fraser Valley Metropolitan Recreation District Administration or staff to contact a doctor for medical or surgical care for my child. Should an emergency arise, the expense of emergency medical treatment or care will be accepted and paid by me.

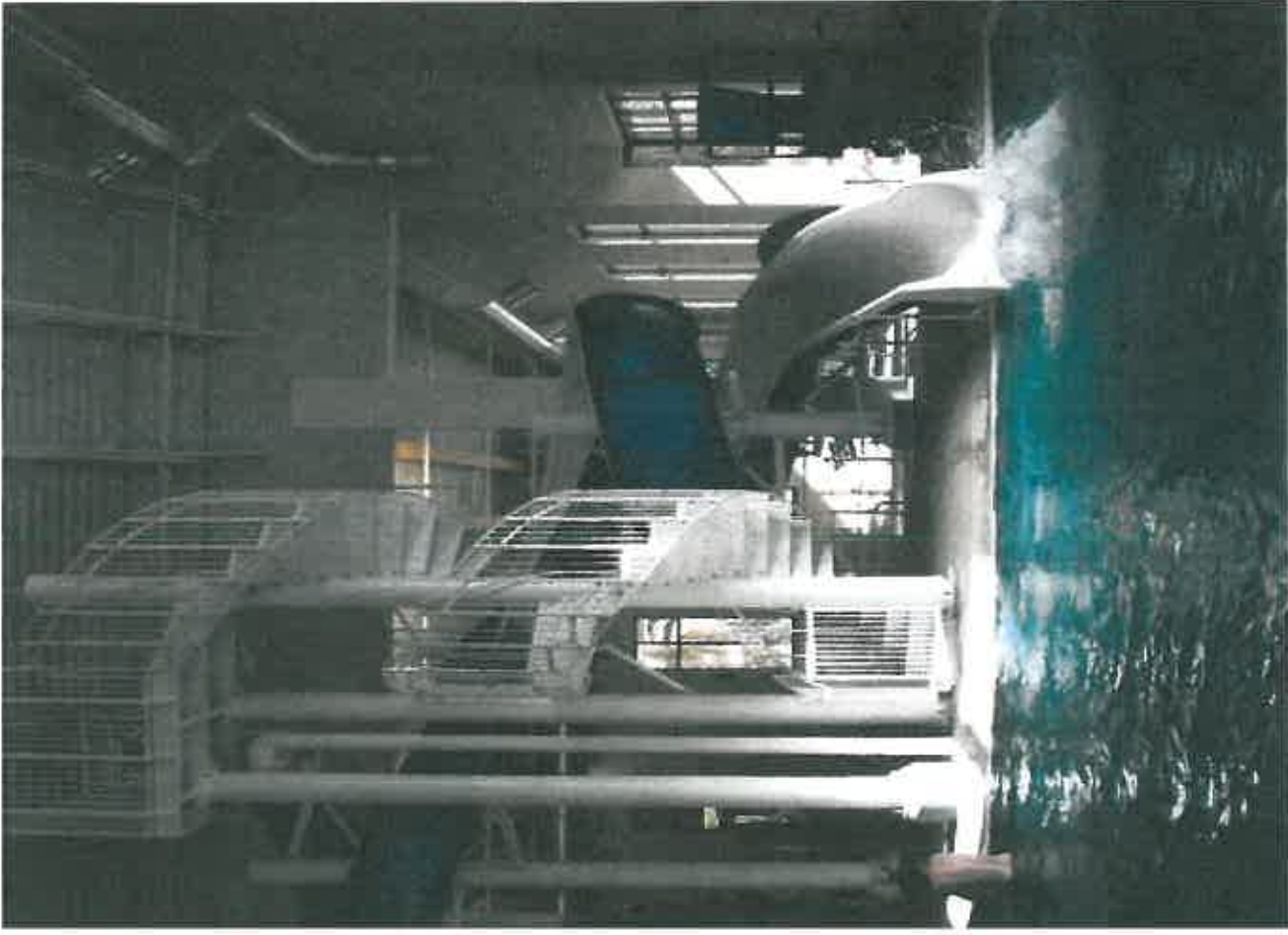
