GENERAL STATEMENT OF DUTIES: Perform a variety of parks maintenance activities, including sports turf repair and maintenance, mowing, irrigation equipment repair, park equipment repair, and trash and debris removal.

ESSENTIAL JOB FUNCTIONS: The following examples are meant to be illustrative only and are not intended to be all inclusive. FVMRD reserves the right to modify the essential functions of this job at any time.

- Perform daily, weekly, and monthly maintenance procedures to assigned parks and facilities.
- Perform athletic field layout and preparation.
- Perform irrigation head, nozzle, and line repair.
- Perform other related duties as necessary.

REQUIRED KNOWLEDGE, SKILLS, AND ABILITIES:

- Knowledge of safety policies, procedures, and practices.
- Knowledge of sports turf management, field layout, pitcher's mound construction, skinned infield maintenance, and common practices.
- Knowledge of the operation of equipment, including tractors w/ various implements, reel and rotary riding mowers, and utility vehicles.
- Knowledge of a variety of hand tools such as chemical spray backpacks, string trimmers, and athletic line sprayers.
- Ability to read and interpret written documents and manuals.
- Ability to communicate clearly and concisely, both orally and in writing.
- Ability to establish and maintain an effective working relationship with staff members, patrons, and the general public.
- Ability to work evenings, weekends, and holidays as necessary.

EDUCATION, TRAINING, AND EXPERIENCE:

- High school diploma or G.E.D. equivalent preferred.
- Two years parks maintenance or horticulture experience preferred.

Work Environment: Work is performed outside in all weather conditions. While performing the duties of this position, the employee occasionally works near moving mechanical parts. The employee will be required to work with chemicals and fertilizers. The employee will be required to read safety data sheets and understand all safety precautions when handling chemicals, fertilizers, or other hazardous materials.

Physical Requirements: While performing the duties of this position the employee is required to walk, stand, sit, kneel, squat, balance, talk, hear, and see. Moderate to heavy lifting and carrying of 20 pounds or greater is occasionally required.
