GENERAL STATEMENT OF DUTIES: Assist with daily golf course maintenance tasks and construction. Safely operate all equipment in the mowing, cultivation, and construction of the golf course.

ESSENTIAL JOB FUNCTIONS: The following examples are meant to be illustrative only and are not intended to be all inclusive. FVMRD reserves the right to modify the essential functions of this job at any time.

- Skillfully operate all maintenance, construction, and mowing equipment safely and efficiently on golf course grounds.
- Assist in the maintenance and construction of facilities on golf course grounds.
- Participate in daily maintenance tasks including course set-up, greens mowing, and bunker grooming.
- Assist in the application of fertilizer and chemicals.
- Assist in the maintenance and repair of irrigation systems. Participate in capital improvements to piping and drainage infrastructure.
- Perform other related duties as necessary.

REQUIRED KNOWLEDGE, SKILLS, AND ABILITIES:

- Basic knowledge of tools, methods, and materials used in golf course and grounds landscape construction and maintenance work.
- Ability to read and interpret written documents and manuals.
- Ability to communicate clearly and concisely, both orally and in writing.
- Ability to establish and maintain an effective working relationship with staff members, patrons, and the general public.
- Ability to work evenings, weekends, and holidays as necessary.

EDUCATION, TRAINING, AND EXPERIENCE:

- Experience in the safe operation of turf maintenance and other motorized equipment.

Work Environment: Work is performed outside in all weather conditions. While performing the duties of this position, the employee occasionally works near moving mechanical parts. The employee will be required to work with chemicals and fertilizers. The employee will be required to read safety data sheets and understand all safety precautions when handling chemicals, fertilizers, or other hazardous materials.

Physical Requirements: While performing the duties of this position the employee is required to walk, stand, sit, kneel, squat, balance, talk, hear, and see. Moderate to heavy lifting and carrying 20 pounds or greater is occasionally required.
